- A lobbyist who does not receive lobbying receipts or make lobbying expenditures is exempt from filing quarterly reports upon filing this statement with the Clerk of the Legislature. **An original and one copy must be filed with the Clerk.**
- A principal who does not receive lobbying receipts or make lobbying expenditures and whose lobbyist does not receive lobbying receipts or make lobbying expenditures is exempt from filing quarterly reports upon filing this statement with the Clerk of the Legislature. **An original and one copy must be filed with the Clerk.**
- All lobbyists must file a Statement of Activity within 45 days after a Legislative Session even if this statement is on file.
- The exemption lapses if lobbying receipts are received or lobbying expenditures made. If the exemption lapses, the obligation to file quarterly reports resumes.

The undersigned lobbyist will file a Statement of Activity (NADC Form D) within 45 days after the end of each regular Session of the Legislature and as otherwise required by law.
